The Board met in regular session at 9:00 AM. Members present: Chairman, Greg Moeller, Gary See and Marc Lindeen.

It was moved by See and seconded by Lindeen to approve the July 10, 2018 Agenda as presented. 3 ayes. Motion carried.

It was moved by Lindeen and seconded by See to approve the minutes of July 5, 2018 as presented. 3 ayes. Motion carried.

Jake Hotchkiss, Engineer, accompanied by Jelen McCall, Office Manager gave the weekly roads update. The Board reviewed a permit for Mt Pleasant Utilities for service to new home on Oakland Mills Rd. Road maintenance July 2nd thru July 6th. Resumed and continued shoulder pull and hauling rock on Merrimac Rd and repaired culvert on 180th St. Continued mowing gravel road shoulders, weed eating around guardrails. Completed painting edge lines and cleaned the machine and switched to yellow paint. Sent a crew out to cold patch in various locations. Crew continues hauling rock this week to Merrimac Rd in preparation for the BASE One Treatment scheduled to start July 16th dependent on the weather. Hwy 218 North bound lane closure was yesterday and for the most part went well. We would like to thank our local sheriff office and the DMV for providing excellent traffic control during the closure. Hwy 78 detour has been delayed until further notice.

It was moved by Lindeen and seconded by See to approve the proposal made by Schumacher Elevator for \$10,460.00 to provide the material and labor to bring the elevator in the Courthouse up to Code by May 1, 2020. 3 ayes. Motion carried.

It was moved by Lindeen and seconded by See to approve the 3rd Reading of Ordinance Amending Waste Water for Bonding of Contractors as follows. 3 ayes. Motion carried.

AN ORDINANCE AMENDING THE HENRY COUNTY ONSITE WASTEWATER TREATMENT AND DISPOSAL SYSTEMS ORDINANCE IN BOOK 262 PAGE 1 TO AMEND SECTION 3 TO ADD DEFINITIONS, AMEND SECTION 4 TO ADD REQUIREMENTS, AMEND SECTION 5 TO REPEAL AND REPLACE SUBSECTION (B), AMEND SECTION 5 TO REPEAL AND REPLACE SUBSECTION (E), AMEND SECTION 6 TO REPEAL AND REPLACE SUBSECTION (A), AMEND SECTION 6 TO INSERT NEW SUBSECTIONS (B), (C), (D), AND (E), INSERT NEW SECTION SEVEN AND RENUMBER REMAINDER IN ORDER, AMEND SECTION NEWLY NUMBERED SECTION 9 TO REPEAL AND REPLACE SECTION, AMEND TITLE V CHAPTER 2 TO REPLACE ALL INSTANCES OF HEALTH DEPARTMENT AND HEALTH OFFICER SHALL BE REPLACED WITH ENVIRONMENTAL HEALTH DEPARTMENT AND ENVIRONMENTAL HEALTH OFFICER RESPECTIVELY.

[Amending Henry County Zoning Ordinance in Book 485 at Page 152]

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF HENRY COUNTY, IOWA:

SECTION 1. SECTION MODIFIED. Title V, Chapter Two, Section 3 shall have the following definition inserted alphabetically and all other definitions re-ordered accordingly,

A. Disposal System Contractor: as used in this ordinance is hereby defined and shall be construed to mean any person, firm or corporation engaged in the business of installing, constructing, reconstructing, repairing, extending or alternating a waste water disposal system.

SECTION 2. SECTION MODIFIED. Title V, Chapter Two, Section 4 shall have the following requirements inserted as subsections D and E:

D. No person, firm or corporation shall engage in the business of a "Disposal System Contractor" in the County without having first obtained a license therefore as herein required. Applications for such license shall be made to the Henry County Environmental Health, upon forms furnished by said Department, setting forth such information therein as to identify the applicant and their background of training and experience.

E. Before such Disposal System Contractor's license shall be issued, the applicant therefore shall file with the Henry County Environmental Health a surety company bond in the sum of at least Ten Thousand Dollars (\$10,000.00), which bond shall be conditioned that the principal therein shall properly observe all the ordinances of the County pertaining to the work of a Disposal System Contractor and all rules and regulations established by the County pertaining to such work, and shall further indemnify and save harmless the County and any and all persons therein for whom such licensee might work as a Disposal System Contractor against all losses and damages that may result by reason of inadequate, improper, or negligent workmanship by the Disposal System Contractor, servants, or employees of same, or by reason of furnishing unsatisfactory material by such licensee or their servants or employees in the performance of any work as a Disposal System Contractor; and a further condition of such bond shall state that the amount of said bond shall be and exist for the benefit of all persons injured or aggrieved by any violation of any ordinance of the County or any neglect to observe the provisions of any such ordinance or the rules and regulations established thereunder. Such bond may be renewable at the time the principal thereon shall renew their Disposal System Contractor license.

Upon failure or refusal of the applicant or licensee to furnish and maintain a bond as herein prescribed, their Disposal System Contractor license shall be revoked.

This bond may be cancelled as to future liability by the Surety upon thirty (30) days written notice to Henry County Environmental Health and the Disposal System Contractor sent by regular mail. The aggregate liability of the Surety to any and all persons, regardless of the number of claims made against this bond or the number of years this bond remains in force, shall in no event exceed the amount set forth above. Any revision of the bond amount shall not be cumulative.

SECTION 3. SECTION MODIFIED. Title V, Chapter Two, Section 5 (B.) shall be repealed entirely and replaced by the following section:

B. Application fee: Before consideration of the application, the applicant shall pay an application fee in an amount set by the Henry County Board of Health by resolution.

SECTION 4. SECTION MODIFIED. Title V, Chapter Two, Section 5 (E.) shall repealed entirely and replaced by the following section:

E. Approval by Environmental Health Officer: Upon approval of the application by the Environmental Health Officer, an on-site wastewater treatment and disposal system permit will be signed and issued. Permits shall expire and have no further validity if the construction or reconstruction or abandonment is uncompleted within a period of one year (six months if complaint based) from the date of issuance. To be valid, the permit shall be signed by the Environmental Health Officer upon initial authorization. No on-site wastewater treatment and disposal system shall be covered or so constructed to prevent final inspection and periodic monitoring by the Environmental Health Officer. A record shall be kept of final inspection results by the Environmental Health Officer.

SECTION 4. SECTION MODIFIED. Title V, Chapter Two, Section 6 (A.) shall be repealed entirely and replaced by the following section:

A. Any person who violates any provision of this ordinance commits a county infraction and shall be subject to the imposition of a civil penalty or other appropriate relief to abate or halt the violation as provided for by 331.307, Code of Iowa. Each day upon which a violation occurs constitutes a separate county infraction punishable by a civil penalty of not more than five hundred dollars for each violation or if the infraction is a repeat offense a civil penalty not to exceed seven hundred fifty dollars for each repeat offense. The County shall be permitted to seek such other relief in addition to a civil penalty as is now permitted pursuant to 331.307, or which may later be permitted upon amendment of 331.307, the Iowa Code.

SECTION 5. SECTION MODIFIED. Title V, Chapter Two, Section 6 shall have the following inserted as new subsections B., C., D., and E:

B. Any licensee who shall (1) neglect or refuse to comply with the provisions of this ordinance or the rules and regulations established thereunder by County ordinance or rules and regulations, or with the conditions under which any permit shall be issued, or (2) who shall falsify any statements in their application for license, or (3) who shall violate any provisions of any ordinance of the County, or (4) who shall violate any provisions of the laws of the state shall be subject to have his license suspended or revoked. Any license herein authorized to be issued may be suspended by Henry County Environmental Health as hereinafter set forth. If such license is suspended, the license and all evidence thereof shall be surrendered by the licensee, and shall be held by Henry County Environmental Health until the final disposition is made of such suspension.

C. It shall be unlawful for the suspended licensee or any one working in their behalf to do any work as a Disposal System Contractor while such suspension continues to exist.

D. In connection with the notice of suspension, a statement in writing shall be prepared by Henry County Environmental Health suspending the license setting forth specifically the charges or grounds for which the license was suspended and the facts on which suspension is based, and such statement shall be served on the licensee at the same time the notice of suspension is served.

E. In the event that a license issued under this ordinance is revoked, such person and all persons officially connected with such license shall be ineligible to obtain another Disposal System Contractor's license in the County for a period of one year from the date of such revocation.

SECTION 6. NEW SECTION. Title V, Chapter Two, Section 7 shall have the following text inserted and all subsequent sections re-numbered in order as follows:

The Board of Supervisor, shall hear and decide appeals from an order to suspend or revoke a license to do business as a Disposal System Contractor. Such appeal shall be taken within a period of not more than thirty (30) days by filing with the Environmental Health Officer and with the Board of Supervisors a notice of appeal specifying the grounds thereof. When notice of the appeal is filed, the Environmental Health Officer shall transmit all of their records or certified copies thereof regarding the appeal to the Board of Supervisors including a copy of the letter suspending or revoking the license to do business as a Disposal System Contractor. The Board of Supervisors shall take action upon this appeal within thirty (30) days. If said Board of Supervisors finds that the basis of suspension is substantiated by the facts, the license shall be revoked forthwith, but if the basis of suspension is not established by the evidence submitted, the license shall be reinstated.

SECTION 7. SECTION MODIFIED. Title V, Chapter Two, Section 8 shall be repealed entirely, renumbered to Section 9 and replaced by the following section:

Variances to these rules may be granted by the Department of Natural Resources or in the case of private sewage disposal systems by the Henry County Board of Health where there is substantial compliance with the standards of these regulations and there have been demonstrated practical difficulties or unnecessary hardships in carrying out the provisions of these regulations.

SECTION 7. SECTIONS MODIFIED. Title V, Chapter Two, All instances of Health Department and health Officer shall be replaced with Environmental Health Department and Environmental Health Officer respectively.

SECTION 8. SAVINGS CLAUSE.

If any section, paragraph, clause, or provision of this regulation shall be held invalid, the invalidity of such section, paragraph, clause, or provision shall not affect the validity of the remaining provisions of this regulation.

SECTION 9. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.

John Pullis, Conservation Director gave his monthly update. Waterworks Park possible campsite update would have 26 pull-through sites, 50 amp power, water and concrete pads the estimated cost for all this and the moving and dirt work was estimated to be approximately \$670,000.00. Cabins are moving along, but will probably not be ready by September as had hoped. They are looking into getting funds that are available to renovate the Ketchum Switch pond to improve for fishing. The Conservation Board approved the Dish subscription for the Office, Shop, Campground Hosts and Cabins.

John Hansen, Midwest Construction was present for a LEC project update and approval of change orders. The Board Chairman signed the already approved Change Order #1 for the \$63,701.56 for Myers Construction. Then he presented Change Order #2 for cost of moving the excess soil across the street for the city you use to put in the walk trail and add 6” subbase of rock for storage building. It was moved by See and seconded by Lindeen to approve Change Order #2 for \$7,270 with Myers Construction. 3 ayes. Motion carried. It was moved by Lindeen and seconded by See to approve a proposal from Mt Pleasant Electric for \$6,700 to wire the Storage Shed. 3 ayes. Motion carried. It was moved by See and seconded by Lindeen to approve a proposal from C & M Cooling & Heating for heating and cooling in the Storage Shed. 3 ayes. Motion carried. The project is moving on schedule.

In other county business the Board reviewed the Recorder’s 2nd Quarter Report. They reviewed the Treasurer’s Annual Report as presented below.
