

NOTICE OF ELECTION
TO THE QUALIFIED ELECTORS OF HENRY COUNTY

In compliance with provision 49.53 of the Code of Iowa, I, Shelly Barber, Commissioner of Elections of Henry County, State of Iowa, do hereby proclaim that on Tuesday, November 4, 2014 a General Election will be held for the purpose of electing candidates for the various offices.

Qualified electors may vote by presenting themselves on November 4, 2014 between the hours of 7:00 AM and 9:00 PM at the polling place for the Precinct of their residence as listed below:

Northwest Precinct will include – Jefferson Township; Wayne Township residents living west of James Ave; and the incorporated cities of Wayland, Coppock and Olds.

Northeast Precinct will include – Scott Township and Canaan Township; Wayne Township residents living east of James Ave; and the incorporated cities of Winfield and Mt Union.

Central Precinct will include – Trenton Township, Tippecanoe Township, Marion Township, Center Township and the incorporated cities of Rome and Westwood.

Precinct 4 will include – Mt Pleasant Ward I

Precinct 5 will include – Mt Pleasant Ward II

Precinct 6 will include –Mt Pleasant Ward III

Precinct 7 will include – Mt Pleasant Ward IV

Southwest Precinct will include – Salem Township, Jackson Township and the incorporated cities of Salem and Hillsboro.

Southeast Precinct will include – New London Township, Baltimore Township and the incorporated city of New London.
